(B) Hearing Officer Manual Policy Memo A5 - Substantial Aggravation: The Commission members and staff discussed proposed Policy Memo A5. The policy would provide that in claims with dates of injury/disability on or after October 11, 2006, the

Hearing Officer should state in the order that the claim is either allowed or disallowed for substantial aggravation of a pre-existing condition and if the issue is abatement of a substantially aggravated condition, that should be stated. The policy would further provide that when allowing a claim for substantial aggravation, the Hearing Officer must cite the evidence which documents the aggravation by objective diagnostic findings, objective clinical findings or objective test results. Hearing Officer Manual Policy Memo C5 - Temporary Total Disability Due to (C) Psychological Conditions: The Commission members and staff discussed proposed Policy Memo C5. The policy would provide that evidence in support of treatment or disability due to psychological conditions must be submitted by a psychologist, a medical doctor or doctor of osteopathy. Hearing Officer Manual Policy Memo 514 - Dual Causation: The Commission (D) members and staff discussed proposed Policy Memo 514. The proposed policy would provide that when adjudicating issues of disability, the allowed conditions must be the disabling conditions. Other non-allowed conditions may be present but if those conditions contribute to the disability in a way that the allowed conditions are not independently disabling, compensation is not proper. The policy would further provide that dual causation does apply to allowance issues. The standard is whether the work related hazard is a proximate cause of the condition. If so, it does not matter what other hazards might also be proximate causes of the condition. Commissioner Thompson moved to adopt Hearing Officer Manual Policy Memo 514, effective May 7, 2007.
