## 2012 Five-Year Rule Review

### DISCUSSION

Nine rules are currently under review by the Commission. These rules are existing rules pertaining to hearing procedures and standards of conduct for adjudicators. Two rules have no changes with amendments being made to the remaining seven rules. These rules have been reviewed by the Rules Advisory Group, E-notification, and the Common Sense Initiative Office (CSI). Mr. Walker noted that no comments were received from outside parties, by the Commission or by the CSI office. There was a recommendation from the CSI office to revise the BIA statement to correct a typo in the BIA statement. The CSI office also recommended that the Commission formally file the proposed rule actions with JCARR.
