A. Five year rule review for the year 2013. The following rules will be reviewed: 4121-1-01; 4121-1-02; 4121-1-03; 4121-3-01; 4121-3-09; 4121-3-32; 4121-3-34; 4121-15-10; 4121-17-07; 4125-1-01

DISCUSSION

No comments were made for rules 4121-1-01; 4121-1-02; 4121-1-03; 4121-3-01, 4121-15-10.

Mr. Connor suggested sending rule 4121-3-09 to the Rules Advisory Group (RAG) in an effort to work out some concerns. Chairperson Taylor, Commissioner DiCeglio, and Commissioner Gillmor agreed to send the rule back to RAG for further review and suggestions.

Rule 4125-1-01 will be rescinded due to several changes. Recommendations from RAG were discussed. RAG would like to add language to paragraph E(3) of the rule. The discussion also involved making changes to paragraph E(1)(c)(i), which includes vocational factors, individual circumstances, and justifiable employment.

RAG is currently exchanging ideas with the IC regarding rule 4121-3-20. The rule will be discussed at a later time.

All the above rules, except for 4121-3-20, will be voted on at the April 2, 2013 meeting. Rule 4125-1-01 will also be discussed prior to voting.
