#### **NEW BUSINESS**

## Medical Exam Manual

Chairman Hughes offered discussion on the new *Medical Exam Manual* and asked if anyone had any questions for the Medical Services Deputy Director, Sara Castle.

Commissioner Taylor asked Ms. Castle whether there were any changes beyond mere grammar or style since the last meeting. Commissioner Taylor asked Ms. Castle to discuss those changes.

Ms. Castle stated that Class 1 of the Mental/Behavioral Exam Section had changes. Specifically, Ms. Castle noted concerns regarding the gaps in class titles and Whole Person Impairment (WPI) percentage. Namely, Ms. Castle noted that the verbiage for Class 1 read no impairment but corresponded with a range between 0% and 5% WPI. Ms. Castle stated that the changes made to the manual closed the gaps and, therefore, a "no impairment" would accordingly relate to a 0% impairment. Ms. Castle stated that she spoke to several psychiatrists and psychologists to confirm the appropriate suggested ranges to ensure they correlated with the Global Assessment Functioning (GAF) scale. Ms. Castle stated that the mental health professionals felt comfortable with the new ranges and did not see any issues in utilizing them for future exams.

Commissioner Taylor also inquired about AMA 5<sup>th</sup> Edition and AMA 2<sup>nd</sup> Edition on the former scale.

Ms. Castle replied that the current table mixed both editions, but that the new manual focused exclusively on the 5<sup>th</sup> Edition.

Commissioner Taylor inquired when the effective date should be and if it should be today.

Tom Connor stated that it should not be a problem.
