To help you locate all of the content you are used to finding, we have created the crosswalk below to help you find the common areas of interest and how to access them.

What are you looking for?	Here’s where to find it on the new site:
<p>ICON</p>	<p>Main ICON page</p> <ul style="list-style-type: none"> From the top navigation menu on any page, click the “Access ICON” link. OR From the footer at the bottom of any page, click the “ICON” link. <p>Individual ICON login pages</p> <ul style="list-style-type: none"> From the top navigation menu on any page, click the “For (Party)” link. Example: “For Workers.” Then click the “Access Your ICON Account” card. OR From the homepage, click the “I’m a (Party)” button. Example: “I’m an Injured Worker”. Then click the “Access Your ICON Account” card.
<p>Office Location and Contact Info</p>	<p>This information is now located on the new Contact Us page.</p> <ul style="list-style-type: none"> From the homepage, click the “I Need to Contact an IC Office” button. OR From the top navigation menu on any page, click on the “About IC” link. Then click the “Contact Us” card. OR From the footer at the bottom of any page, click the “Contact Us” link.
<p>Industrial Commission News</p>	<p>Current IC news, Notices of Meetings, policy updates, etc. are now located in the new Card Carousel news section on the homepage.</p> <ul style="list-style-type: none"> From the homepage, scroll down to the News & Updates section. The cards are clickable and will take you to the articles. You can also scroll through the cards by clicking the left and right arrow buttons. <p>Previous news, Notice of Meetings, updates, etc.</p> <ul style="list-style-type: none"> Click the “View More News & Updates” link underneath the News Card Carousel. OR From the footer at the bottom of any page, click the “News & Updates” link.
