Resolution R18-1-03

VSSR Exemption Resolutions Rescinded Because of Statutory, Administrative, Case Law, or Policy Changes

September 26, 2018

WHEREAS, R.C. 4121.03(E) provides that the Industrial Commission is responsible for the establishment of the overall adjudicatory policy of the Industrial Commission; and

WHEREAS, the Ohio Industrial Commission has adopted resolutions setting forth policy on various subject matters; and

WHEREAS, the Industrial Commission desires to update its resolutions and rescind any resolution that is no longer valid due to changes in the Ohio Revised Code, the Ohio Administrative Code, Ohio case law, or other policies adopted by the Industrial Commission; and

WHEREAS, HB 222 transferred the responsibilities of maintaining the division of safety and hygiene from the Ohio Industrial Commission to the Bureau of Workers' Compensation BWC by revising R.C. 4121.37. Am.Sub.H.B. No. 222, 1989 Ohio Laws File 106. HB 222 revised RC 4121.13 to make it the responsibility of the Bureau of Workers' Compensation, rather than the Industrial Commission, to "[a]scertain and fix reasonable standards and prescribe, modify, and enforce reasonable orders for the adoption of safety devices, safeguards, and other means or methods of protection to be nearly uniform as possible" The legislature also amended R.C. 4121.47 to reflect this policy.
